Proenol – Indústria Biotecnológica, SA, hereby declares that all our **ENCAPSULATED YEASTS** (ProElif, ProDessert, ProMalic, ProRestart):

Genetic Modification (GMO)

Are neither Genetically Modified Organisms, nor are manufactured from raw materials or ingredients of GMO origin

Irradiation

Were not submitted to ionising radiation treatment, and do not incorporate irradiated ingredients

Allergens

Do not contain the substances or products causing allergies or intolerances, referred in the annex II of the Regulation (EU) 1169/2011

Nanotechnology and Nanomaterials

Have not been produced with the use of nanotechnology and do not contain any engineered nanomaterials, as defined in article 2.2 of Regulation (EU) 1169/2011

Dioxins

According to section 5 of Commission Regulation (EC) No 1881/2006, there is no limit requirement for these products or their ingredients on dioxin levels.

The manufacturing process of the aforementioned products is not susceptible of releasing dioxins, nor were they manufactured using raw materials or processing aids supposed to have dioxins
