ABSENCE: 2. Crustaceans and products thereof;

ABSENCE: 3. Eggs and products thereof;

ABSENCE: 4. Fish and products thereof, except: (a) fish gelatin used as carrier for vitamin or carotenoid preparations; (b) fish gelatin or Isinglass used as fining agent in beer and wine;

ABSENCE: 5. Peanuts and products thereof;

Soybeans and products thereof, except: (a) fully refined soybean oil and fat (1); (b) natural mixed tocopherols (E306), natural D-alpha tocopherol, natural D-alpha tocopherol acetate, and natural D-alpha tocopherol succinate from soybean sources; (c) vegetable oils derived phytosterols and phytosterol esters from soybean sources; (d) plant stanol ester produced from vegetable oil sterols from soybean sources;
